## Company overview

Signature HealthCARE is a leading provider of long-term nursing care in the United States with 20,000 employees and 126 locations spanning 10 states. Their mission is to radically change the landscape of healthcare forever.

# The problem

Signature HealthCARE were operating over 55 unique entities and growing steadily. Each entity had a separate database, all within Microsoft Dynamics GP. As they grew, accounting staff became bogged down with accounts payable (AP) redundancies. Administration had become a time-consuming burden and they needed a solution which could handle their rapid growth and eliminate redundant processes.
